



# **SPEAKER BIOGRAPHIES**

### Kiswana Alexander, LMSW (she/her pronouns)

Kiswana is the Youth Substance Use Treatment Coordinator at the LGBT Community Center's Center Youth Recovery. Kiswana provides individual counseling services, facilitates group therapy, and coordinates OASAS documentation and outreach opportunities for Center Youth Recovery. In her free time, she enjoys going to the beach.

#### Liliane Drago MA, CASAC, MAC, Director

Liliane is the Director of the Outreach Training Institute, the largest provider of CASAC training in the New York region. In that capacity, she oversees the program in its two locations and serves on the teaching faculty. She was formerly Vice President and National Training Director for Phoenix House, where she was responsible for training and staff development, and the adoption of evidence-based practices into treatment programs. She is a member of the Motivational Interviewing Network of Trainers (MINT), a competency-based affiliation which was created by the developers of MI, a certified trainer on the Addiction Severity Index (ASI), and an associate trainer in Seeking Safety Therapy for post-traumatic stress disorder.

Previously, she directed the Riverside Center at Phoenix House, a treatment program for employed adults with substance use disorders and their families, the Director of Ambulatory Programs, where she provided oversight of adolescent outpatient services, and was Adjunct Instructor in Behavioral Science at Mercy College. Ms. Drago regularly facilitates professional development trainings for Outreach's own clinical staff, as well as clinicians in healthcare and behavioral health, and conducts workshops at professional conferences. She holds a master's degree in Community Psychology from New York University, is a Master Addiction Counselor (MAC) and a Master Credentialed Alcoholism and Substance Abuse Counselor.

## Saeeda Lesley Dunston, Executive Director

Saeeda was appointed the Executive Director at Elmcor Youth and Services Activities, Inc. in August 2014. She is recognized among her peers and human service providers throughout New York State, as having the depth and breadth of programmatic, administrative knowledge- in developing and implementing culturally competent programs and services. Attributes significant in not only prompting transformative change within organizations where she was employed but through her professional skills sets, empathetic and insightful understanding of the challenges encountered by marginalized communities, empower individuals and families to become change agents and engaged participants in their communities.

Ms. Dunston has devoted her career to channeling and directing her commitment to service, unparalleled work ethic, laser-like ability to ascertain the bottom line to develop and implement strategies that ensure communities and most specifically communities and populations of color are provided with the tools to live productive, healthy and aspirational lives.

With her longevity and commitment to working in the nonprofit sector, Ms. Dunston's leadership will not only secure Elmcor's position as a vital service provider and advocate on the neighborhood level, but through ongoing capacity building efforts, she will be instrumental in building collaborative relationships with individual, public and philanthropic communities to support and invest in those around areas of mutual concern and priority.

Prior to Elmcor, Ms. Dunston served in senior management positions in Brooklyn multi-service agencies; served several boroughs and citywide advocacy and policy focused coalitions that address poverty, anti-racism, health care needs of marginalized populations and communities throughout New York City. These experiences mobilized and retrofitted at Elmcor in developing and enhancing new and existing programs: Science Technology Engineering Mathematics (STEM). Program, that provides exceptional learning and out-of-school time opportunities to youth to pursue post-secondary education and careers in STEM fields; launched the Queens Community Connection, a borough-wide consortium of service providers, leveraging organizational resources to address the prevailing socio-economic-health disparities that challenge Queens communities; and; promote inter- and intra-agency collaborations around issues of behavioral health, health equity, social and economic justice, anti-stigma and community education.

Ms. Dunston is a graduate of York College, has post graduate certifications in program management, leadership/professional development, and fundraising. She is also a proud wife, mother, grandmother underscoring the deep personal and familial ties and connections to Queens and in particular the East Elmhurst/Corona communities.

## Tracie Gardner, Vice President of Policy Advocacy

As Legal Action Center's Vice President of Policy Advocacy, Tracie directs LAC's Policy Advocacy work, spearheads major initiatives and fosters strategic partnerships that support LAC's mission. Tracie has worked more than 30 years in the public health, public policy, and not-for-profit fields as a policy advocate, trainer, and lobbyist. She has led advocacy campaigns that achieved substantial increases in funding and landmark policy reforms in the areas of substance use, HIV, alternatives to incarceration and reentry services, and community and correctional health. She is currently a board member of NEXT Distro and Outreach Drug and Alcohol Treatment Services.

From 2015 to 2017, Tracie served as the Assistant Secretary of Mental Hygiene for New York State where she oversaw the State's Office of Alcoholism and Substance Abuse Services, Office of Mental Health, Office for People with Developmental Disabilities, the Developmental Disabilities Planning Council, and the Justice Center for the Protection of People with Special Needs. Prior to her appointment by the Cuomo Administration, Tracie was a key member of the Legal Action Center for more than 14 years, serving as LAC's Co-Director of Policy. In this role, she conducted and coordinated LAC's New York State public policy advocacy in the areas of substance use disorders, criminal justice, and HIV and AIDS. Tracie received a BA from Mount Holyoke College.

#### Commissioner Arlene González-Sánchez, MS, LMSW

Commissioner Arlene González-Sánchez, MS, LMSW, was appointed Commissioner of the New York State Office of Addiction Services and Supports (NYS OASAS) by Governor Andrew M. Cuomo on Jan. 3, 2011.

Commissioner González-Sánchez has more than 30 years of experience in the fields of behavioral health services administration, health policy development, and medical research. Under the Commissioner's leadership, OASAS works to realize her vision for transforming the current system of care for individuals with substance use disorders into a comprehensive, patient-centered and family-focused system. Commissioner González-Sánchez serves on the Governor's Medicaid Redesign Team (MRT) Behavioral Health Subcommittee. She is co-chair of the State's Behavioral Health Services Advisory Council and a co-chair of the Responsible Play Partnership which addresses problem gambling in New York State. Governor Cuomo also appointed Commissioner Arlene Gonzalez-Sanchez to serve as Member of the Council for SUNY Empire State College for a term to expire on June 2024.

To help ensure that culturally competent services are available to address the specific needs of various populations, Commissioner González-Sánchez has been instrumental in the establishment of numerous helpful programs for these communities. This includes first-of-its-kind adolescent substance use disorder clubhouses and recovery centers in various counties across the state such as The Lesbian, Gay, Bisexual and Transgender Community Center in New York City and The Pillars Recovery Center in Harlem. She also provided funding and support for multiple youth clubhouses and one recovery center serving the Native American Community. Additionally, she expanded specialized outreach by launching the educational program "Nueva Esperanza, Nueva Vida con OASAS" which aired in Spanish on Telemundo and Univision. This programming was the preface for the "New Hope, New Life with OASAS" television broadcast which was developed for a broader audience to inform and educate New Yorkers about addiction prevention and recovery services, substance use disorder and the reduction of the associated shame and stigma.

Commissioner Arlene González-Sánchez was named to City & State's 2020 Health Power List (15th) which includes 100 of the most powerful people in the health care community. She was also named to their 2019 Nonprofit Power 100 List (34th) which honors the 100 most influential people working in nonprofit organizations focusing on civil rights, criminal justice, health care, education, immigration and legal services.

On a national level, Commissioner González-Sánchez serves as the First Vice President of the National Association of State Alcohol and Drug Abuse Directors (NASADAD) Board.

#### Raul Russi, President & CEO

Raul is the President & CEO of Acacia Network. With an annual operating budget exceeding \$750 million, Acacia Network comprises more than 100 affiliates and over 2,700 employees across seven states and Puerto Rico, and serves more 150,000 individuals every year through five principal programmatic areas, mainly Primary and Behavioral Health, Transitional Housing, Affordable Housing, Community Development and Social Enterprises. Raul's vision and leadership carried the organization during a critical period of growth over a decade ago, paving the way for Acacia Network to become one of the leading human services organizations in New York City and the largest Hispanic-led nonprofit in the State. An expert in mergers, acquisitions, and affiliations, Raul created a model that is now being utilized as a gold standard across the social services field, while preserving critical community assets that would have otherwise been lost.

Originally from Patillas, Puerto Rico, Raul migrated to Buffalo, New York at the age of 12 with his parents and eight siblings. As a young Puerto Rican living in a community that lacked diversity, he became keenly aware at an early age about the importance of helping underserved communities gain a "seat at the table." Raul became a police officer in Buffalo during the 1970s, at a time when Latinos and African Americans were grossly underrepresented in the police force. He went on to become one of the most decorated officers in the history of the department and, after getting shot in the line of duty, subsequently held different leadership and Cabinet-level positions in the public sector, including Chairman of the New York State Parole Board and CEO of the Division of Parole during Governor Mario Cuomo's administration, as well as Sheriff of New York and Commissioner of the NYC Department of Probation during the administration of Mayor Rudolph Giuliani.

During his years on the police force, Raul was actively involved in the nonprofit sector, playing a key role in the affiliation of multiple Hispanic organizations in the Buffalo area. In 1973, he created the Consortium of Spanish Speaking Organizations, the first full-service agency headed by a Puerto Rican/Latino in Buffalo, followed by the founding of the Western New York Hispanic and Friends Civic Association. He provided the leadership and spearheaded the creation of Western New York's first residential substance abuse treatment program, Horizon Village, and later incorporated and chaired the board of La Alternativa, Buffalo's first Hispanic-based substance abuse prevention program. He then merged La Alternativa with two other organizations to create Buffalo's largest Hispanic Organization, Hispanos Unidos de Buffalo, which joined Acacia Network as an affiliate in 2011. These early experiences with the affiliation model taught him that there is strength in numbers, especially when it comes to serving and representing minority communities.

In 2001, he became the Executive Director of Basics, Inc., and subsequently spearheaded the affiliation with Promesa, Inc. in 2009, which led to the creation of Acacia Network. Under his visionary leadership, Acacia Network grew to become one of the largest Hispanic-led human services nonprofits in the Nation, saving hundreds of thousands of lives every year through a wide array of integrated, culturally responsive programs that include Primary Care; Mental Health and Addiction Services; Residential Treatment for At-Risk Populations; Affordable and Supportive Housing; Transitional Housing; Early Childhood Education; Afterschool Programs and Youth Development; Senior Services; Workforce Development; Arts and Culture, and more. He further expanded Acacia Network's portfolio and footprint by launching several for-profit ventures that aimed to serve as revenue streams for the nonprofit arm.

Today, Raul feels that his vision has been nearly realized, as Acacia enters a new phase of growth and expansion. He continues to work tirelessly to open doors and advocate for Puerto Ricans and Latinos at large, in order to ensure that the next generation continues this important work to reinvest in our communities by bringing innovation, creativity, and most importantly, "To get the job done!"

Raul Russi has four children and lives in Manhattan with his wife, Rody Reyes-Russi, and his youngest son, Joshua.

## Commissioner Ann Marie T. Sullivan, M.D.

Dr. Ann Marie Sullivan is currently the Commissioner of the New York State Office of Mental Health. She has also served as Associate Director of Psychiatry and Medical Director of Ambulatory Care at the Gouverneur Diagnostic and Treatment Center in Manhattan, NYC.

Dr. Sullivan grew up in Queens, New York City. She graduated from NYU and its School of Medicine and completed her Psychiatric Residency at New York University/Bellevue Hospital in 1978. Dr. Sullivan is a Distinguished Fellow of the American Psychiatric Association and has served as the Speaker of the American Psychiatric Association's Assembly. She is a Clinical Professor at the Mt Sinai School of Medicine, a fellow of the New York Academy of Medicine, and a member of the American College of Psychiatrists.

Dr. Sullivan is an active advocate for her patients, her profession, has published and lectured on best practices in community psychiatry.

Mr. Turner's recovery and activism are anchored and maintained upon the same harm reduction principles of EXPONENTS' - "meeting" folks where they're at and not leaving them there."
