## **Professional Peer Certification? Follow these Steps**

Limited number of scholarships available to cover training cost, certification application fees, and exam fee:

· Certified Recovery Peer Advocate (CRPA) only

Minimum of 46 hours NYCB-approved training - choice of, CCAR Recovery Coach Academy (30 hours) plus Peer Ethics (16 hours), or a single custom-designed training program. Find trainings at https://for-ny.org/upcoming-trainings/

#### Billing status of CRPA, CRPA-Provisional and CRPA-Family:

Peer recovery professionals providing eligible services under these certifications continue to be Medicaid-reimbursable for remote service provision (teleconference, videoconference, etc.). #### **Certification Applications:**

- Applications for Professional Certification (CRPA; CRPA-Provisional; CRPA-Family; CARC) are being accepted via email only.
- When preparing your application, please be sure that you have completed the most recent version of the application and role verification form(s) (May 2020). These forms have been specially designed to be completed and signed online. Please email your completed application to Elisabeth Kranson, Certification Coordinator at <a href="mailto:ekranson@asapnys.org">ekranson@asapnys.org</a>.
- Online applications must be accompanied by credit card payment please make your payment at https://tinyurl.com/yayengxm.
- If you have questions about how to submit your application, please contact NYCB staff.
- The NYCB Board continues to meet remotely, and applications are being processed and approved as usual. Please allow 4-6 weeks for turnaround.
- Professional Certifications continue to be issued in the usual manner.

#### **Certification Status & Renewals:**

All expiration dates falling in the period March 1-June 30, 2020 will be automatically extended by 90 days to ensure that all certificants remain in status. These extensions are posted to our website Certification Verification page as appropriate on a rolling basis - please check your status at http://www.asapnys.org/verify-a-certification/.

- Online peer recovery support qualifies as role experience hours towards the 500 hours required for CRPA (and CRPA-Provisional upgrade). Be sure to document your voluntary and/or paid hours.

## **IC&RC Peer Recovery Exam**

Please note that testing sites for the IC&RC Peer Recovery exam (required for CRPA and CRPA-Upgrade) are reopening.

If you are ready to apply for CRPA, or to upgrade from CRPA-Provisional, and you are just waiting to test, please take the following action:

#### **CRPA-Provisional Standards**

- The primary value of CRPA-Provisional continues to be its utility as a Medicaid-reimbursement platform. However, CRPA-Provisional is NOT required to build the 500 hours experience in the peer recovery role required for CRPA. Role practice hours in non-Medicaid-reimbursable environments also count. Keep careful track of these hours; you will be required to document them in support of your CRPA application.
- Pending full restoration of the IC&RC Peer Recovery Exam, NYCB cannot guarantee timing of an award of full CRPA. If you need to be immediately Medicaid-reimbursable, please apply for the CRPA-Provisional.
- Effective April 1, 2020, candidates for CRPA-Provisional will not need to be working in the role at time of application to be eligible for this professional certification. Candidates must, however, meet the experiential and educational requirements of the role.
- Please note that CRPA-Provisional expires after 24 months (plus any temporary extension awarded on the basis of the present emergency). The certification is non-renewable. If applying for CRPA-Provisional, please be confident that you will be able to complete 500 hours role experience, plus pass the associated competency-based exam (when restored), within the non-negotiable timeframe of the certification.

#### **Certified Addiction Recovery Coach (CARC)**

We are continuing to process CARC applications in the usual manner. For options to complete the 60 hour training requirement, please see <a href="http://www.asapnys.org/ny-certification-board/renewal-program/">http://www.asapnys.org/ny-certification-board/renewal-program/</a>.
