# Interview with Elisabeth Kranson

#### Newly Appointed Director of Certification at the New York Certification Board



A native of California, who also boasts Swedish ancestry, Elisabeth came to New York state as the mother of two young children, now teenagers preparing for college life. Experienced in advertising in the competitive markets of Los Angeles and San Francisco, Elisabeth settled in the capital district in 2012. She joined ASAP in 2015, assisting ASAP Executive Director, John Coppola, as well as organizing several successful conferences for the New York Society of Addiction Medicine.

Elisabeth was appointed NYCB Certification Coordinator a year later. In this role, she was responsible for reviewing all certification applications, providing customer service, maintaining records, processing payments, and generally ensuring smooth passage for candidates through the review/approval process.

Elisabeth holds a BA in Business/Economics from the University of California, Santa Barbara. She is currently completing studies as an Institute for Credential Excellence (ICE) Certified Credentialing Specialist.

The NYCB team of Cathie, Doug, Ruth, and myself are here to help. We are working from home at the moment, but we haven't missed a beat so far. We are doing our best to maintain our excellent level of customer service, to help people through each step of the certification process.
