To be eligible for full CRPA certification, a candidate must meet the following requirements (* also required for CRPA-Provisional):

- 18+ years *
- High School Diploma, or equivalent, or higher *
- 46 hours approved foundational training in role practice *
- 500+ documented hours role experience providing peer recovery support to those with Substance Use Disorder (SUD); including
- 25 documented hours of being supervised in individual (one-on-one) or group sessions
- Passing grade in IC&RC Peer Recovery competence-based exam (scheduled upon certification approval)

In Certemy, NYCB's online database, both the **CRPA** and **Upgrade to CRPA** applications require the candidate's supervisor, manager or mentor to complete the *Role Experience and Supervision* form.

When they reach this step in the application process, candidates will be prompted to invite their supervisors via Certemy to complete this section electronically.

Supervisors will receive an email from the candidate's Certemy account with instructions on how to proceed electronically in accessing and completing the supervisor *Role Experience and Supervision* form on behalf of the candidate.

In preparing for this section, and to best supervise candidates generally, we encourage supervisors to review the appended CRPA role competencies (56 items incorporating the knowledge, skills and abilities of competent performance in the peer recovery advocate role). This

competencies (56 items incorporating the knowledge, skills and abilities of competent performance in the peer recovery advocate role). This review will help to determine the activities that meet the work experience requirement for CRPA certification, and will aid a supervisor in answering the questions in the *Role Experience and Supervision* form

In completing the form, both the candidate's job title and job description will need to be included.

Some CRPA candidates may work with clients who have co-occurring diagnoses in mental health and SUD. Only hours providing peer recovery support for those with substance use disorder meet the requirement for CRPA certification.

Certification Renewal Program

Renewal Standards

Step 1 - Complete Continuing Education Training

Any training taken after 1/1/21 for CARC or CRPA renewals, MUST be NYCB approved, or they will NOT be accepted for renewal. Please see the lists on the right for NYCB-approved training opportunities. There are trainer-led and computer-based courses. The minimum continuing education hours required for renewal are as follows:

- CRPA: 28 hours recovery-specific education (multiple courses); *including*, 4 hours peer ethics. CASAC ethics will not be accepted for the ethics requirement.
- CARC: 18 hours recovery-specific education (multiple courses); *including*, 3 hours peer ethics. CASAC ethics will not be accepted for the ethics requirement.

Step 2 - Submit a Renewal Application

When you have completed the required training, please submit your renewal application using our new digital application processing platform called Certemy. To begin your CARC and/or CRPA renewal application, please log into your Certemy account using the following link: https://nycb.certemy.com/entry/login and submit your online renewal application, continuing education certificates, and payment. You will be able to complete the entire application process online using any device or computer. If you need assistance accessing your Certemy account, please email support@certemy.com. Renewal applications received within 45 days of the expiration date are subject to a \$25 late fee. Please note that payments are non-refundable and expire 1-year after submission, if candidates do not complete the renewal process.

The approval process can take up to four weeks from receipt of your application. Incomplete applications, or applications without payment/scholarship will be on hold until complete. The Certemy system will send reminders if steps are incomplete. Once a renewal application has been approved, your new certificate will immediately be available in your "Digital Wallet" in your Certemy account for you to download and/or print.
