## NEW-MAT Certification Requirement

Medication Assisted Treatment (4 hours)



"From April 1, all applicants for initial certification will have to include a training completion certificate for 4 hours Medication Assisted Treatment (MAT)," said **Eilsabeth Kranson**, ASAP-NYCB Director of Certification, announcing this new standard.

#### **MAT & Trainers**

Preparing Students for the New Requirement

"This is a great opportunity for trainers to develop an original MAT training," says **Ruth Riddick**, Program Manager of the ASAP-NYCB Trainer Registry. "We're always looking for trainings that support purposeful conversations regarding recovery pathway options, including Medication Assisted Recovery."

"Trainers also have the following options to support certification candidates navigating this new requirement," she continued:

- Advise them of the CARC and CRPA 4-hour MAT requirement and refer them to the approved foundational training list at <a href="http://www.asapnys.org/nycb-approved-training/">http://www.asapnys.org/nycb-approved-training/</a>
- Engage a colleague member of the ASAP-NYCB Trainer Registry to deliver an approved MAT training for

"This is a one-time requirement," she continued. "Current certificants will have to submit 4 hours MAT when renewing their certifications. If you have previously taken 4 hours of MAT, that course may be accepted."
