
#### **Target Audience**

|                     | The attacks of September 11, 2001, prompted the creation of a robust and deadly special operations force — Task Force Dagger.   |  |  |  |  |  |
|                     | Alan C. Mack, Callsign Razor 03, led one of two teams of MH-47E helicopters and armed MH-60s. Their two-fold mission – Personnel Recovery (PR) and Unconventional Warfare(UW) involved flying in terrain and weather previously not thought possible.   |  |  |  |  |  |
|                     | But, if that wasn't enough, they pushed the flight envelope of thei specially modified Chinooks to the limit and beyond.  |  |  |  |  |  |
|                     | Alan shares his behind-the-scenes perspective of the Horse Soldier's infil into Afghanistan. He discusses the hunt for Usama Bin Laden at Tora Bora and describes his shootdown during Operation Anaconda. |                     | Gambling has been a part of the U.S. military since the Civil War. Leaders of the Union and Confederate Armies spoke on the maleficence associated with gambling within its ranks.  |  |  |  |  |  |
|                     | Although ingrained in military culture, gambling is associated with risk and co-occurring conditions linked to military service. One of these risks is suicide. As a population, Veterans are at an increased risk for suicide. Problem gambling behavior has the highest rate of suicidal behavior than other addictions. |                   | The Social Determinants of Health are categorized under 5-Domains all of which will be touched upon. However, the workshop will focus specifically Social and Community Context . Drawing upon what is known to impact health (specifically mental health) in this domain, the workshop will make clear distinctions between mental health and mental illness (these terms are not interchangeable), as well as focus on a very critical component of mental health that requires more targeted and focused discussion-"emotional well-being."  |
|                   | Self-harm within the veteran community, which remains one of the veterans' most serious health concerns, will be explored but only to contextualize the theme, which is the very critical and inextricable role of emotional well-being that often goes "underlooked."  |
|                   | Lastly, the workshop will elicit ideas from the audience about how to engage in "wellness checks" of newly separated veterans and/or how to reach those who have seemingly adjusted to civilian life. The workshop will seek to draw attention to red flags, changes in demeanor/behavior, isolative behavior, and other indicators of changes in one's mental health and emotional well-being.   |
